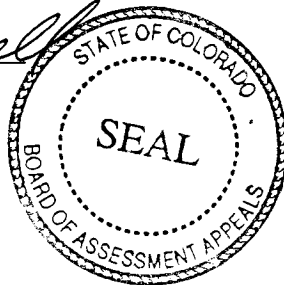

6. The valuation, as established above, shall be binding only with respect to tax year **2001**.




8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on **November 15, 2001 at 10:30 A.M.**
