5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following tax year 2001 actual value for the subject property:

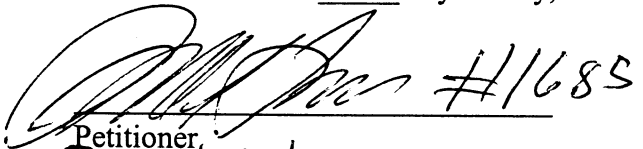

7. The reduction in value reflected in this stipulation is based on an appraisal and reduction in value of personal property already accounted for in another schedule.

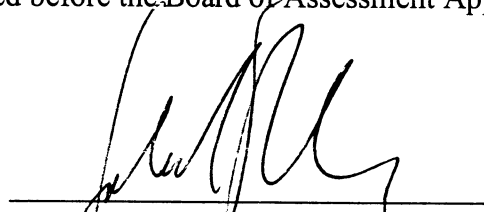
8. A hearing has not yet been scheduled before the Board of Assessment Appeals.

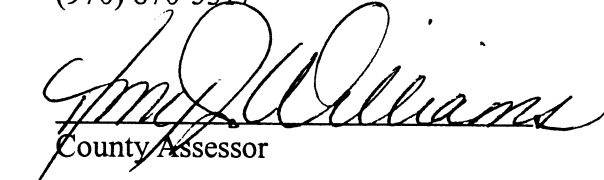
