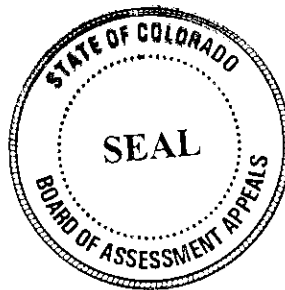

Both parties agree that the hearing before the Board of Assessment Appeals be vacated or a hearing has not yet been scheduled.


