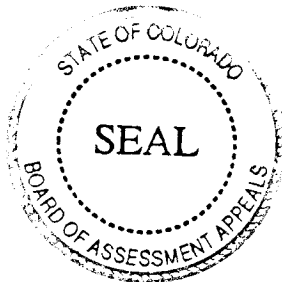

STIPULATION (As To Tax Year 2001 Actual Value)	

Petitioner, SRR CORPORATION, and Respondent, Denver County Board of Equalization, hereby enter into this Stipulation regarding the tax year 2001 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

4920 Washington Street
Denver, Colorado
2. The subject property is classified as commercial property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2001:

Land	\$ 630,800
Improvements	<u>\$ 397,000</u>
Total	\$1,027,800

4. After appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 630,800
Improvements	<u>\$ 397,000</u>
Total	\$1,027,800

5. After further review and negotiation, the Petitioner and Board of Equalization agree to the following actual value for the subject property for tax year 2001:

Land	\$ 630,800
Improvements	<u>\$ 59,200</u>
Total	\$ 690,000

6. The valuations, as established above, shall be binding only with respect to tax year 2001.

7. Brief narrative as to why the reduction was made:

The property is in poor condition and actual income supports a lower value.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 8, 2001 at 10:30 a.m. be vacated.
