Respondent is ordered to reduce the 2002 actual value of the subject property, as set forth above.



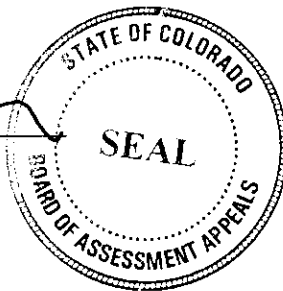

6. The valuations, as established above, shall be binding only with respect to tax year 2002.


7. Brief narrative as to why the reduction was made:

The value of the subject property was adjusted by the BAA for the 2001 tax year. That same value is being stipulated to for the 2002 tax year.


