
2. Petitioner is protesting the 2002 actual value of the subject property.


Petitioner's request for withdrawal is granted; therefore, the Board will take no further action on these matters.


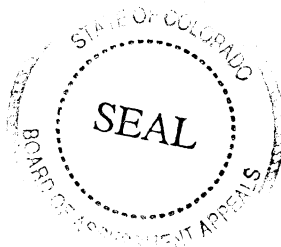
