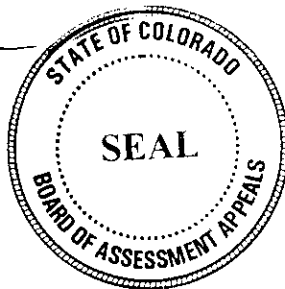



5. After further review and negotiation, Petitioner(s) and Board of County Commissioners agree to the following tax year 2001/2002 actual value for the subject property:


