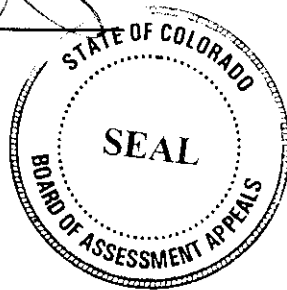

A brief narrative as to why the reduction was made: Analyzed market information.




