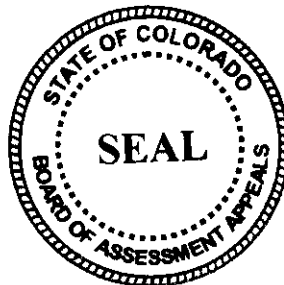

Total:	\$466,000.00

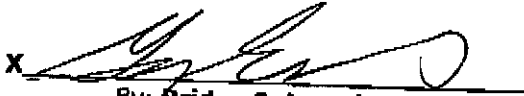
6. The valuation, as established above, shall be binding only with respect to tax year **2003**.

The owner's actual income, supplied by the agent, supports reduction to the total property value.

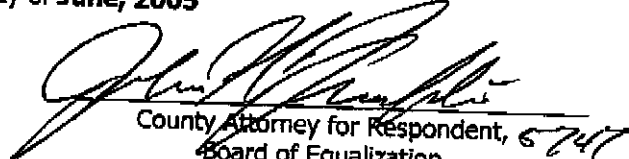
