Petitioner and Respondent hereby enter into this Stipulation regarding the tax year 2003 valuation of the subject property and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner and Respondent agree and stipulate as follows:

I. The property subject to this Stipulation is described as:

Lot 2, Block 1 Parker Central Area #5 Replat, 0.701 AM/L

- 2. The subject property is classified as Commercial property.
- 3. The County Assessor originally assigned the following actual value on the subject property for tax year 2003:

Land	\$ 458,040
Improvements	\$1,441,960
<b>Total</b>	<b>\$1,900,000</b>

- 4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 458,040
Improvements	\$1,156,960
<b>Total</b>	<b>\$1,615,000</b>

- 5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2003 actual value for the subject property:

Land	\$ 458,040
Improvements	\$ 841,960
<b>Total</b>	<b>\$1,300,000</b>


- 6. The valuations, as established above, shall be binding only with respect to tax year 2003.


- 7. Brief narrative as to why the reduction was made:
