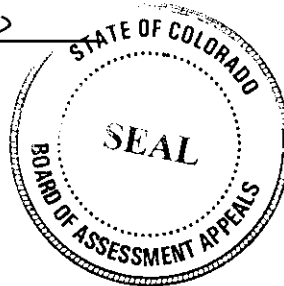

Subject property is classified as residential and described as follows: 4100 E. Quincy Ave.; County Schedule Number 2075-07-2-03-001; RA 2189.


A brief narrative as to why the reduction was made: Analyzed market information.


