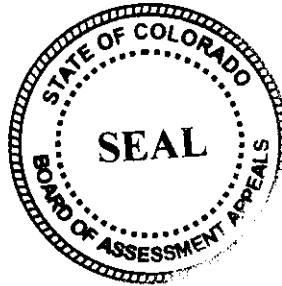

Subject property is classified as residential and described as follows: 10 Red Fox Ln.; County Schedule Number 2075-17-2-08-003; RA 642-062.



The parties have agreed that the 2003 actual value of the subject property should be reduced as follows:


