7. Brief narrative as to why the reduction was made:

Reduction is granted due to an anlysis of the subject property in relation to the comparables used. A review of the subject indicated that it was valued on the high end of the spectrum. The subject is a newly constructed home, which was estimated to be at 75% complete for 1/1/2003. Values have steadily increased in the Forest Road area, but due to a relatively limited number of sales of newly constructed, high-end homes in this very exclusive area, the data is inconsistent and difficult to analyze satistically. The recommended value reflects the value of the improvements at 75% complete, and brings the subject's value in line with the median of the comparables used in the analysis.

8. Both parties agree that the hearing scheduled before the Board of Assessment appeals on March 26, 2004 at 10:30 a.m. be vacated.
