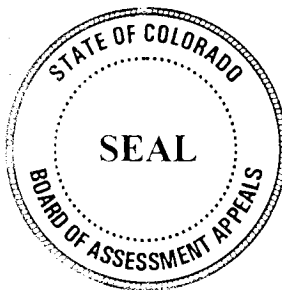

Subject property is classified as warehouse/storage described as follows: 2153 W. Wabash St; Schedule Number 1973-28-1-02-010 RA 3871-003.




The parties have agreed that the 2003 actual value of the subject property should be reduced as follows:
