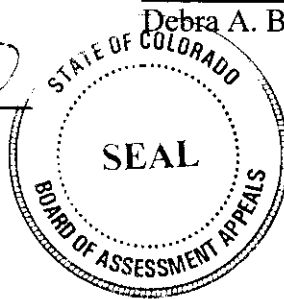

7. Brief narrative as to why the reduction was made:


Reconsideration of comparable sold apartment properties indicates a reduction in valuation is warranted.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 13, 2006 at 8:30 a.m. be vacated.
