6. The valuations, as established above, shall be binding only with respect to tax year 2003.


7. Brief narrative as to why the reduction was made:

An adjustment was made to the actual value to equal the adjusted 12/1999 sale price of the subject property.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 3, 2005 at 3:00 p.m. be vacated.
