- > In an effort to be fair to all of our patients, the procedure physician will most likely not be seeing you after the procedure. Your follow up appointment with the physician ordering this procedure is the time to share the outcome of the procedure.

 - ✓ Since IV anesthesia will be used to help you relax, you must have a driver to transport you to and from the facility.
 - ✓ DO NOT take NSAIDs (such as: Aspirin, Motrin, Ibuprofen, Aleve, Naprosyn) 72 hours prior to your injection. If you are unsure if you are taking one of these medications, please ask your doctor or a Centeno Clinic staff member.
 - ✓ If you are on prescription blood thinners that don't require blood test monitoring (such as Plavix), then you must stop these a full week prior to the procedure. You should clear this with the doctor that ordered the medication. If you are on any prescription blood thinners that require blood-test monitoring (such as Coumadin or Warfarin) then you must tell a physician at the Centeno Clinic who will need to speak with your doctor before proceeding.
 - ✓ Stagger your pain medication dosage so it is not at it's peak during your visit. One goal of the procedure is to identify whether the procedure made a difference and then evaluate how much difference it made.
