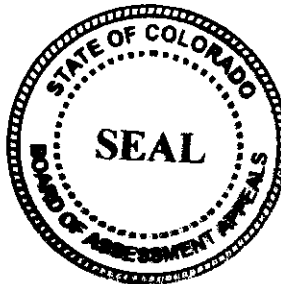

6. The valuations, as established above, shall be binding only with respect to tax year 2003.


7. Brief narrative as to why the reduction was made:

The value of the subject property was adjusted to the base period sale price (\$1,750,000).


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 20, 2005 at 8:30 a.m. be vacated.
