6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

Additional consideration of the condition of the subject property indicates a lower value should be assigned for ad valorem purposes.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 6, 2005 at 1:00 p.m. be vacated.
