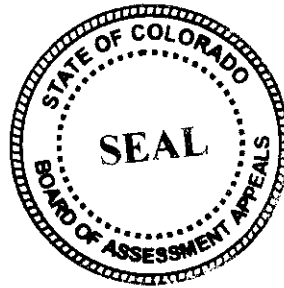

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

Additional physical and functional obsolescence was applied to recognize the buildings general condition and limited utility.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 15, 2005 at 8:30 a.m. be vacated.
