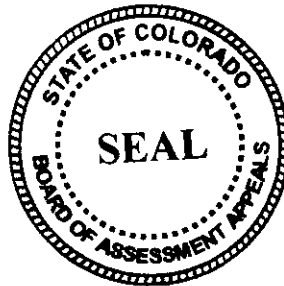

STIPULATION (As To Tax Year 2003 Actual Value)

SMII TRP Properties, LLC,
Petitioner,

vs.

Jefferson County Board of Equalization,

Petitioner and Respondent hereby enter into this Stipulation regarding tax year 2003 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as a commercial property located at 165 South Union Boulevard, Lakewood, CO
2. The subject property is classified as an office building.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2003:

Land	\$ 4,357,700
Improvement	<u>\$17,430,600</u>
Total	\$21,788,300

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the property as follows:

Land	\$ 4,065,400
Improvement	<u>\$16,261,800</u>
Total	\$20,327,200

5. After further review and negotiation, Petitioner and Board of Equalization agree to the following tax year 2003 actual value for the subject property:

Land	\$ 3,722,500
Improvement	<u>\$14,889,700</u>
Total	\$18,612,200

6. The valuation, as established above, shall be binding only with respect to tax year 2003.
7. The value reduction was made because the Assessor's Office utilized the incorrect building rentable area and over estimated the building's potential rental rate with respect to calendar years 2000, 2001 and 2002.
8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 25th, 2005, at 8:30 a.m. be vacated.




