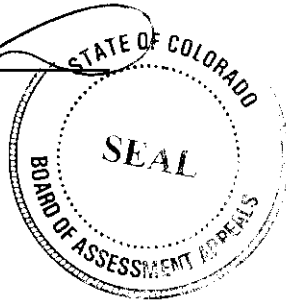

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2003.

6. The valuations, as established above, shall be binding only with respect to tax year 2003.


7. Brief narrative as to why the reduction was made:

An adjustment was made to the base rental rate with emphasis placed on the actual income.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 29, 2006 at 1:00 p.m. be vacated.
