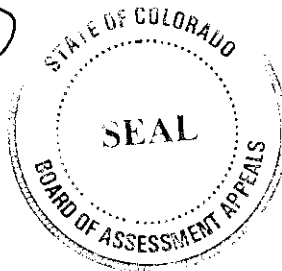

6. The valuations, as established above, shall be binding only with respect to tax years 2003 and 2004.


7. Brief narrative as to why the reduction was made:

The value of the subject adjusted due to a review of the actual income for the subject property. The actual income indicates a value less than the current assigned value.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 5th, 2006 at 1:00 p.m. be vacated.
