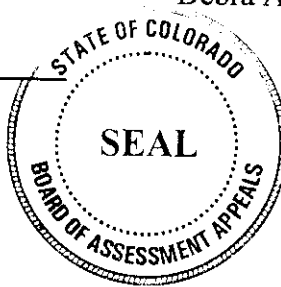

7. Brief narrative as to why the reduction was made:


Sales support a market value of \$1,675,000.
