STIPULATION (AS TO TAX YEAR 2004 ACTUAL VALUE)

COME NOW The Petitioner, Corrections Corporation of America, by and through its undersigned attorney, Kenneth S. Kramer of Berenbaum, Weinshienk & Eason and the Respondent, Kit Carson County Board of Equalization, by and through its undersigned attorney, Wade H. Gateley, and hereby enter this Stipulation regarding the tax year 2004 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner and Respondent agree and stipulate as follows:

- 1. The property subject to this Stipulation is described as: Tract #3, Burlington CCA Annex Unplatted, Burlington, Colorado, also known as the Kit Carson Correctional Center, 49777 County Road V, Burlington, Colorado 80807, and 65 acres of agricultural land, located in Kit Carson County, Colorado.
- 2. The subject property is classified as commercial property, and agricultural land.

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2004:

Agricultural land \$6,089.00 Improved Commercial Land \$32,744.00 Commercial Improvements \$29,961,167.00 Total \$30,000,000.00

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Agricultural land \$6,089.00 Improved Commercial Land \$32,744.00 Commercial Improvements \$29,961,167.00 Total \$30,000,000.00

5. After further review and negotiation, the Petitioner and the County Board of Equalization agree to the following tax year 2004 actual value for the subject property:

Agricultural land \$6,089.00 Improved Commercial Land \$32,744.00 Commercial Improvements \$27,461,167.00 Total \$27,500,000.00

- 6. The valuation, as established above, shall be binding only with respect to tax year 2004.
- 7. Brief narrative as to why the reduction was made: The Respondent Kit Carson County Board of Equalization retained an expert witness to re-appraise the property. However, based on the fact that 2004 is an intervening year, the valuation was negotiated between the parties. Both parties agree that statutory interest shall be added to any refund of taxes paid.
- 8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on Monday and Tuesday, September $12^{\rm th}$ and $13^{\rm th}$ shall be vacated.
