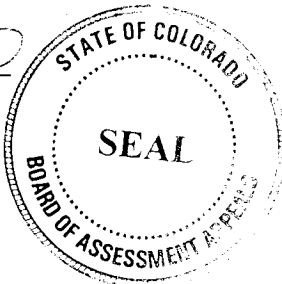

Reconsideration of comparable sales.


