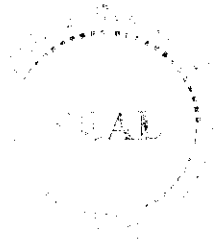


7. Brief narrative as to why the reduction was made: After analyzing the information requested by the motion of discovery, a reduction is warranted.
