

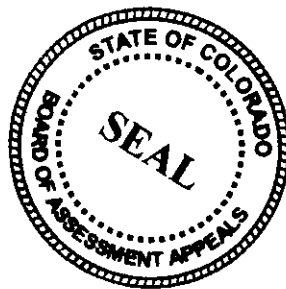

<b>STIPULATION (AS TO TAX YEAR 2004 ACTUAL VALUE)</b>	

Petitioner, ROBERT F. AND DARLENE A. HEAD, and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enters into this Stipulation regarding the tax year 2004 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as industrial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2004.

Land	\$	190,900.00
Improvements	\$	<u>306,200.00</u>
Total	\$	497,100.00

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

Land	\$	190,900.00
Improvements	\$	<u>306,200.00</u>
Total	\$	497,100.00

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2004.

Land	\$	190,900.00
Improvements	\$	<u>209,100.00</u>
Total	\$	400,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2004.

7. Brief narrative as to why the reduction was made:

The subject property's valuation was reduced to \$400,000 via a 2003 BOCC hearing, Docket #24903. The 2004 valuation will be reduced to reflect a similar value.


8. A hearing has not been scheduled before the Board of Assessment Appeals.
