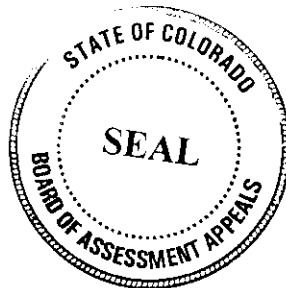

Subject property is classified as residential and described as follows: 4100 E. Quincy Ave.; County Schedule Number 2075-07-2-03-001; RA 74-076.




The parties have agreed that the 2004 actual value of the subject property should be reduced as follows:


