4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2003.

6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

The actual income for the subject property declined significantly at the end of the base period. The decline in actual and economic income supports a lower value.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on September 26, 2006 at 1:00 p.m. be vacated.
