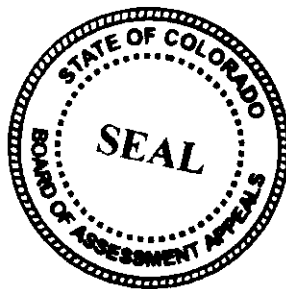

Reconsideration of comparable market sales.


8. A hearing has not been scheduled before the Board of Assessment Appeals.
