

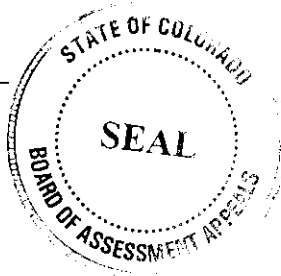

The 2004 valuation has been reduced to reflect the stipulated value for 2003.


8. A hearing has not been scheduled before the Board of Assessment Appeals.
