The Denver County Assessor is directed to change his/her records accordingly.

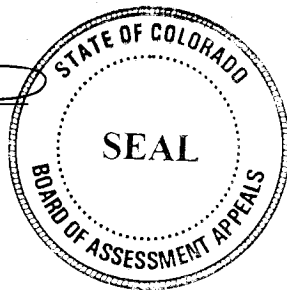



6. The valuations, as established above, shall be binding only with respect to tax year 2004.


