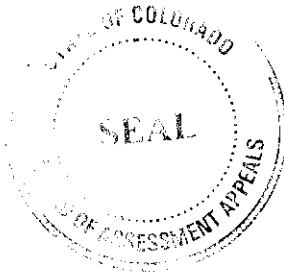

7. Brief narrative as to why the reduction was made:


The value of the subject property was adjusted based on additional market information that was supplied by the petitioner.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 6, 2007 at 8:30am be vacated.
