The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 9, Bell Mountain Ranch #1B, 11.270 AM/L

2. The subject property is classified as Residential property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2005:

Land	\$326,250
Improvements	\$534,280
Total	\$860,530

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$326,250
Improvements	\$534,280
Total	\$860,530

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2005 actual value for the subject property:

Improvements	\$423,750
Total	\$750,000


6. The valuations, as established above, shall be binding only with respect to tax year 2005.

7. Brief narrative as to why the reduction was made:


Further review of market approach indicated a lower valuation.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 31, 2006 at 9:30 a.m. be vacated.


