5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2005 for the subject property:


Land	\$ 152,100

6. The valuation, as established above, shall be binding only with respect to tax year 2005.


7. Brief narrative as to why the reduction was made: Reduction to market value. Subject is a rental property, and after discussing several comparables in the neighborhood, we agreed that a value of \$549,000 was fair. Subject was purchased August 9, 2002 for \$549,000.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 9, 2006 at 8:30a.m. be vacated.


