Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
6425 Washington St., Denver, CO, Adams County
2. The subject property is classified as commercial property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2005:

Land	\$ 396,080
Improvements	\$ 2,952,940
Total	\$ 3,349,020

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 396,080
Improvements	\$ 2,674,100
Total	\$ 3,070,180

5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2005 for the subject property:


Land	\$ 396,080

6. The valuation, as established above, shall be binding only with respect to tax year 2005.


7. Brief narrative as to why the reduction was made: Reduction to income value.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 7, 2007 at 1:00 p.m. be vacated.


