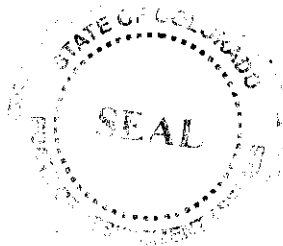

Therefore, the property is deemed unbuildable. Adjustments for the subject property were decreased from \$220/acre to \$95/acre.
