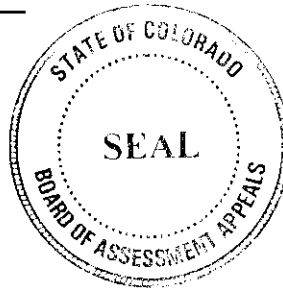

6. The valuations, as established above, shall be binding only with respect to tax year 2005.

7. Brief narrative as to why the reduction was made:

Reduce the improvement value to a token value of \$1,000. The subject is an under improved parcel when considering the income approach to value the property.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals be vacated.
