7. Brief narrative as to why the reduction was made:


Review of the original comparable sales used by the Assessor versus those submitted for review by the petitioner indicates an overvaluation.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 11, 2007 at 8:30am be vacated.
