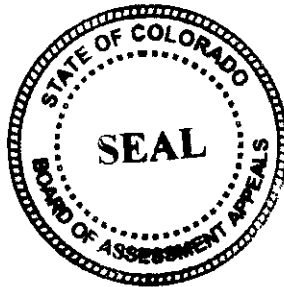

7. Brief narrative as to why the reduction was made:


The change was made in recognition of the property's actual income and expenses from the 2003 and 2004 years representing the 2005 base period.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 28, 2007 at 8:30am be vacated.
