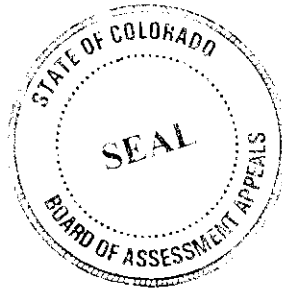




8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 7, 2007 at 3:30pm be vacated.
