7. Brief narrative as to why the reduction was made:


Upper level is owner occupied and the basement is leased. Rental rates support the stipulated value.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 15, 2007 at 10:30am be vacated.
