6. The valuations, as established above, shall be binding only with respect to tax years 2005 and 2006.


7. Brief narrative as to why the reduction was made:


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 26, 2007 at 1:00pm be vacated.
