6. The valuations, as established above, shall be binding only with respect to tax year 2005.

The value was reduced based on actual income from the assigned base period and the allocation was corrected to 45% Residential and 55% Commercial.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 18th, 2007 at 8:30am be vacated.
