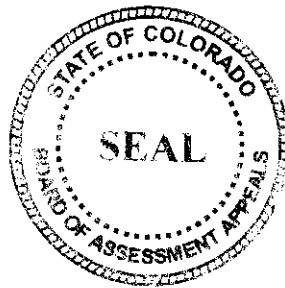

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2005.

6. The valuations, as established above, shall be binding only with respect to tax year 2005 / 2006.


7. Brief narrative as to why the reduction was made:
Both parties agree to a value of \$113,529/unit based on the actual rents received for the 2005 base year and a previously stipulated value on a property at 8155 Fairmont Drive.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 8, 2008 at 8:30 AM be vacated.
