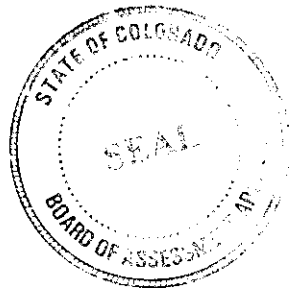



7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of schedule number(s): 2005 for the assessment years(s) covered by this Stipulation.


