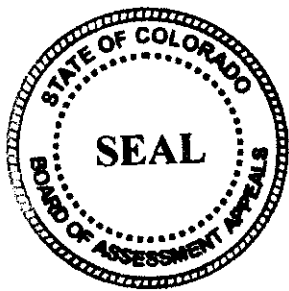




8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 16, 2007 at 10:30am be vacated.
