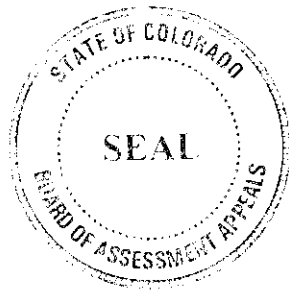

6. The valuations, as established on Attachment C, shall be binding with respect to only tax year 2006.


7. Brief narrative as to why the reduction was made:

8. Both parties agree that a hearing was not scheduled before the Board of Assessment Appeals.


