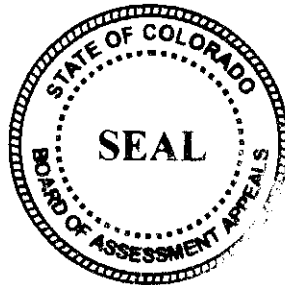

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax years 2005 and 2006.

6. The valuations, as established above, shall be binding only with respect to tax years 2005 and 2006.

7. Brief narrative as to why the reduction was made:

Additional weight was given to the potential gross income (PGI) with consideration to both actual and market rents. A mutually agreed upon gross rent multiplier (GRM) was then applied.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 11, 2007 at 8:30am be vacated.
